5.2 Regulations Bylaw and Water System Fees and Charges Bylaws for Regional District Owned Water Systems – Central Okanagan East and Central Okanagan West

Staff report dated November 4, 2015 outlined that first reading was provided at the Board's October 26th meeting so as to provide the Directors with additional time to review the consider the proposed water bylaws. The question on who votes on the bylaws was raised. The Administrator stated as per the *Local Government Act* Section 791(11), when "only one director would be entitled to vote, each director who is present (a) is entitled to vote, and (b) has one vote." Director Carson requested a copy of the legal opinion which staff will provide.

Subsequent discussion from the October 26th Board meeting:

- Rate increases were presented at the open houses.
- Fees and charges are related to recovery of the costs of the service. Asset renewal would need to be used if full operational costs are not recovered.
- Operating fees in the past have not been high enough to cover the cost of services.
- Water systems must be funded appropriately.
- Rates must be at a sustainable level.
- The area director noted that Falcon Ridge residents she has recently spoken to are concerned about the increase. It was noted that costs of the service must be covered by the residents receiving the specific service.
- The question was raised why there have been operational losses? It is because the rates were not high enough to cover the cost of the service provided to the residents.
- The 'world of providing water' has radically changed from 20 years ago. IHA has new regulations that must be adhered to and there are significant liability issues to be concerned about.
- Other local governments are faced with similar rate increases.
- It would be reckless to not properly fund the operation of each service.

6.2 Curbside Waste Collection Contract – 3-Year Extension (*All Directors* – *Weighted Vote*)

Staff report dated November 3, 2015 outlined the three-year extension option for the cubside waste collection contract. The contract extension complies with our obligations for competitive bidding under the New West Partnership Trade Agreement (formally TILMA). The extension will keep the program aligned with its member municipalities whom have previously extended their contracts providing economies of scale required for competitive financial rates and a high level of service.

The contract is based on per unit (\$117.72 per household) the same rate no matter where the household is located

7.1 RDCO 2015 – 2019 Financial Plan Amending Bylaw No. 1380, **1**st, **2**nd **and 3**rd **reading and Adoption** (*All Directors* – *Weighted Vote*)

Staff report dated October 27, 2015 outlined the amendment required to fund the Westshores Water System – Reservoirs Capital Project. The addition of a second reservoir will increase costs from the projected \$318k to \$848K, funding coming from reserves. Staff will be reviewing the possible use of Community Works Funding in 2016 to reduce costs for this project.

The reservoirs have always been on the 20-year asset renewal plan. The design dollars have been able to be stretched because there is a significant project in Westshore. Staff believes the cost of the second reservoir will be reduced by including it in the proposed larger project underway in 2016.
