**6. PARKS SERVICES**

- 6.1 Proposed Regional Trails Service (*All Directors - Unweighted Vote - LGA 208.1*)

Staff report dated March 1, 2016 outlined background information regarding a proposed regional trails service program. The Governance & Services

Committee had received a delegation by the Central Okanagan Trails Alliance (COTA) on November 12, 2015. The Board subsequently authorized staff to develop a more detailed work program associated with investigating establishment of a new service.

At this time, staff has determined that there is insufficient organizational and financial capacity to support establishing a new regional trails program. Staff is encouraging the non-profit recreational trails community to seek out alternative funding and partnerships for recreational trail development.

Province of BC Flood Protection Grant – Woodhaven Nature Conservancy  
Regional Park

THAT the Regional Board approves the 2016 Regional Parks program General Capital Fund Budget be amended to include an additional \$300,000 in capital expense – contingent on receipt of the provincial funding - to complete a flood protection project on Bellevue Creek located within Woodhaven Nature Conservancy Regional Park;

AND FURTHER THAT revenue to offset the above noted capital expenditure will be secured through receipt of a \$200,000 Province of BC Flood Protection Grant and the allocation of \$100,000 from the Regional Parks Capital Facilities Reserve Fund.
