## REPORT

### PURPOSE:

This report provides an estimate of the total number of eligible electors within the Killiney Beach Recreation Buildings Local Service Area.

### NUMBER OF ELIGIBLE ELECTORS:

Number of eligible electors is determined to be **2,099**.

### ELECTOR QUALIFICATIONS:

Qualified electors are:

- 18 years of age or older;
- a Canadian citizen;
- a resident of B.C. for the past 6 months prior to signing the documents;
- a resident (Resident Elector) of the jurisdiction for 30 days prior to signing the document; or
- must reside in a different jurisdiction (Non-Resident Property Elector) but have owned a property in the jurisdiction for 30 days prior to signing the document.
- Non-resident property electors are individuals who own property, either as joint tenants or tenants in common and are not holding the property in trust for a corporation or another trust. No corporation is entitled to be registered as an elector or have a representative registered as an elector and no corporation is entitled to vote.

Properties include vacant, non-vacant and residential lands, as determined by the British Columbia Assessment Authority, situated in the Killiney Beach Recreation Buildings Local Service Area. Vacant lands exclude institutional and infrastructure parcels.
